

5 YEAR LIMITED WARRANTY

SSHC, Inc. warrants to the original purchaser that the ENERJOY® Radiant Heatmodule is free of defects in material and workmanship for a period of 5 years, or 2 years for panels with operating voltages exceeding 277 volts from the date of purchase. If your Heatmodule has a defect within the terms of this warranty, SSHC, Inc. will repair, or at its option, replace the defective Heatmodule. In order to obtain service under this Warranty, simply contact the dealer from whom you purchased the ENERJOY Radiant Heatmodule or SSHC, Inc. at the address listed below. To act on the warranty, the defective panel must be returned to SSHC, Inc. for testing at the purchaser's expense. The cost of returning the repaired or replacement panel will be the responsibility of SSHC, Inc. The warranty period for any repaired or replacement part or module is limited to the unexpired portion of the original warranty period.

WARRANTY LIMITATIONS

SSHC, Inc. will not be responsible for labor or service charges incidental to the removal and replacement of a defective part or module. The warranty does not apply to any panels that have been physically altered by the purchaser, damaged during the handling or installation process, exposed to an electrical overload or water damaged. Reinstallation of panels at other than the original location voids warranty.

WARRANTY

This Warranty is LIMITED STRICTLY to the terms indicated herein and no other express warranties or remedies there under shall be binding on us. ALL WARRANTIES WHICH MAY BE IMPLIED UNDER STATE LAW, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY AND WARRANTIES OF FITNESS FOR ANY PARTICULAR PURPOSE, SHALL BE LIMITED TO FIVE YEARS FROM THE DATE OF PURCHASE. IN NO EVENT SHALL SSHC, Inc. BE LIABLE FOR CONSEQUENTIAL OR SPECIAL DAMAGES FROM BREACH OF THIS WARRANTY OR ANY OTHER WARRANTY WHICH MAY BE IMPLIED BY LAW. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, AND SOME STATES DO NOT ALLOW THE EXCLUSION OF CONSEQUENTIAL OR SPECIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION THEREOF MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

It is a condition to warranty coverage that the ENERJOY Radiant Heatmodule be installed by a licensed electrician in accordance with the provided installation instructions and local electrical codes. Failure to do so will preclude warranty coverage.
